Death Of Typography Foundry Trial Font License

1.1 Introduction

Death of Typography's Trial Font End User License Agreement (EULA) is an agreement between You (You, Your, You're, Yours) and DTHTYPE (Death of Typography) trading as Death of Typography (Death of Typography) when You download the Trial Fonts (the Trial Fonts). By purchasing, downloading, installing, or using the Trial Fonts, You accept the terms of this agreement. If You do not wish to accept these terms, do not purchase, download, install, or use any Trial Fonts from Death of Typography.

1.2 Format

The Trial Font is provided only in OTF (.otf) with a limited set of characters and do not include any OpenType features.

2.1 Permitted Use

This agreement allows You to:

- 1. Install Trial Fonts on any number of devices within Your organisation or Household.
- 2. Use Trial Fonts exclusively for test prints or web designs with protected access to help You decide if the font is suitable for Your needs before purchasing a commercial license.
- 3. Use and publish Trial Fonts in any non-commercial Student works.
- 4. Use Trial Fonts to create proposals within Your organisation or to clients for project pitches but not for commercial artwork production.

2.2 Forbidden Use

This agreement does not allow You to:

- 1. Use Trial Fonts for any projects for commercial purposes.
- 2. Distribute Trial Fonts to any Third Party outside of Your organisation.
- 3. Sublicense, sell, rent or distribute and disseminate the Trial Fonts privately, publicly or through any online or third party services.
- 4. Reverse engineer, decompile or disassemble the Trial Fonts.
- 5. Sub-license, sell, rent or distribute and disseminate any digital files derived from our Trial Fonts.
- 6. Rename, modify, edit or create derivative works of the Trial fonts or to commission a Third Party to do so.

3.1 Liability & Termination

Any breach of the terms and conditions in this EULA will result in the immediate termination of Your license to use the Trial Fonts without the opportunity to remedy or cure. After any termination of the agreement, You shall immediately and irretrievably delete the Trial Fonts from any workstations You have installed it on. You may be asked to certify that You have compiled with this obligation through writing.

3.2 Final Provisions

If any provision of this EULA is invalid, illegal or void for any reason, such provision will be severed from the EULA. All other provisions in this EULA will not be affected and will remain valid and enforced.

Death of Typography cannot be held responsible for any damage caused by You and/or any third parties resulting from a breach of this agreement and misuse of the Fonts themselves.

Death of Typography reserves the right to modify or edit any part of this EULA at any time without prior notice. Any original terms stated in this EULA will not be void, and modified terms will be made available on deathoftypography.com. If You do not agree to the modified terms, Your continued use of the Fonts could be in breach of the EULA, and Your license will be terminated if the breach is verified.

This Agreement shall be governed by and construed in accordance with the law of Singapore, and international IP laws shall have exclusive jurisdiction to settle any dispute or claim.
